All of these skills are a part of an office professional's responsibilities. **Information.** You must be skillful in acquiring, evaluating, organizing, maintaining, interpreting, and communicating information. You must also use computers to process information. All of these skills are a part of an office professional's responsibilities. **Systems.** You must understand how social, organizational, and technological systems work and operate effectively within them by monitoring and correcting performance and often improving and designing simple systems such as managing mail systems and setting up and managing filing systems. **Technology.** You must be able to work with a variety of technologies, which involves collecting procedures, tools, or equipment, including computers and related technologies. You should understand the intended use of the technology and the proper procedures for its setup and operation as well as how to maintain and troubleshoot problems.
